Handicap, be a member in good standing of a member club or association, and be a bona fide resident of the Commonwealth of Kentucky with a valid Kentucky Drivers License or an I.D. issued by a college or university within the boundaries of the state of Kentucky unless the eligibility of any such entrant shall be otherwise determined by the Board of Directors. The current handicap index shall be based on records effective on the revision date of July 1, 2009.
